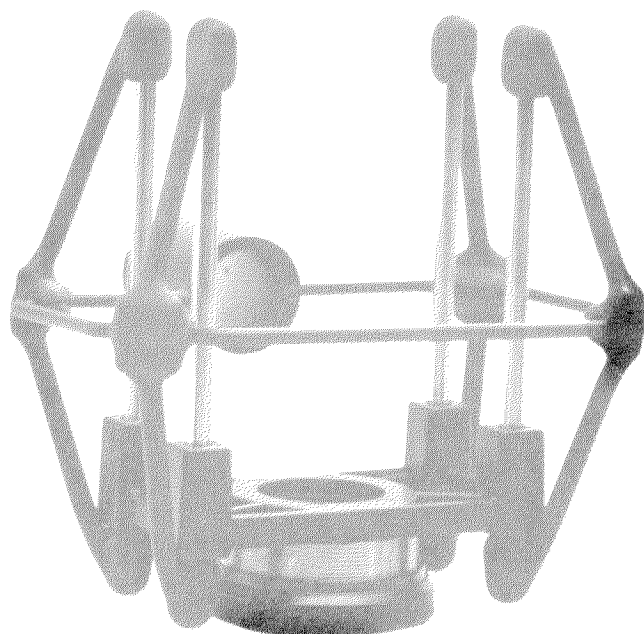

Suspension Shock Mount for RE1000

- Excellent isolation from mechanical vibration
- Optimized design for the RE1000
- This insert replaces foam insert to accommodate both microphone and shock mount within the RE1000 carrying case

Description and Application

The 325 shock mount is a high performance shock mount intended for use when excessive mechanical vibration is encountered. It is equally effective in an upright or hanging position. The unique gripping mechanism holds the microphone securely without requiring tools and without damaging the finish of the microphone. The stud on the rear of the shock mount accommodates the stand clamp originally provided with the microphone. The shock mount is also supplied with a new foam insert for the RE1000 carrying case, allowing the user to store the shock mount with the microphone.

Shock Mount Use

1. Screw stand adapter into stand or boom (standard 5/8-27 thread). Position the adapter to the desired location.
2. Slide the shock mount into the stand adapter.
3. Slide the shock mount forward. Position the shock mount to the desired angle and tighten the threaded knob on the stand adapter.

4. To position the RE1000 in the shock mount, slide the connector end of the microphone into the compression holder. The threaded cap must be loose for the microphone to fit into the rubber.

Replacement parts

Should the rubber suspensory ligaments (shock cords) wear out through excessive use, deteriorate due to atmospheric conditions, or in any way change, new ones may be ordered from Electro-Voice, Inc., Buchanan, MI 49107, attention: Miscellaneous Parts Department. Request part number 16696. You will be billed for the cost.

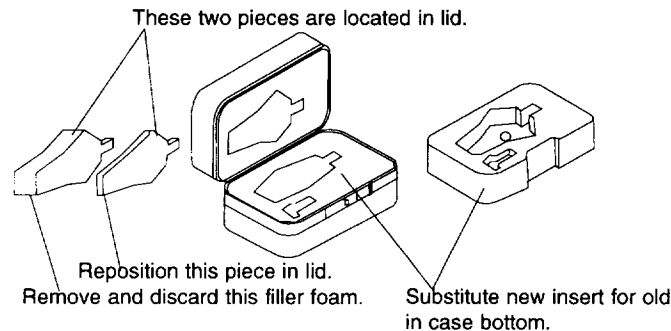
