

#### **DESCRIPTION AND APPLICATIONS**

The Electro-Voice 319 suspension shock mount was designed specifically for use with the RE38N/D microphone. The 319 provides effective shock isolation for the RE38N/D microphone. A stand adapter with 5/s-27 thread is provided and will attach directly to the recording boom, spring-loaded microphone arm or floor stand.

The 319 suspension shock mount allows quick installation of the RE38N/D microphone without tools. To install the RE38N/D into the 319

shock mount, slide the connector barrel of the RE38N/D into the compression clamp of the 319. Rotate the threaded cap of the 319 compressing the rubber gland until tight.

#### ASSEMBLY

Figure 2 provides an assembly guide. Each friction washer (item 4) should be placed on the outside of the bail (item 2), to provide a contact surface for the shoulders of the two wing bolts (item 3).

Additional shock isolation can be obtained by using the flexible coil cord supplied. Attach three-pin audio connectors at each end of the cable. Secure the male connector (equipment end) to the bail or boom to limit the shock noise transmitted through the cable to the microphone.


#### REPLACEMENT PARTS

Should the neoprene suspensory (shock) cords or gland wear out through excessive use, deteriorate due to atmospheric conditions, or in any other way require changing, new ones may be ordered from Repair Department, Electro-Voice, Inc., Buchanan, Michigan 49107 (616/695-6831 or 800/234-6831).

FIGURE 1 - Dimensions



In addition, the Limited Warranty for the acoustic system contained in these microphones shall apply for the life of the product, defined as a period of ten (10) years from the date that the manufacture of the specific microphone has been discontinued. Any and all active electronics incorporated in these microphones are guaranteed against malfunction due to defects in materials or workmanship for a period of three (3) years from the date of original purchase. The Limited War-

ranty does not extend to cables, cable connectors, or switches. Additional details are included in the Uniform Limited Warranty statement.
